The Centre for Interdisciplinary Research in Music Media and Technology (CIRMMT) is quickly establishing itself as one of the major centers of excellence in the science and technology of music, with a unique combination of scientists, technologists and musicians working in collaborative projects. CIRMMT includes Quebec researchers in science, engineering, medicine and music from three institutions: McGill University, the University of Montreal and the University of Sherbrooke.
