# THE LAW SCHOOL ENDOWMENT

As of December 2012, the fair market value of The Dickinson School of Law’s endowment was just over \$44 million. This total is attributed to individual endowments established by our alumni and friends for student scholarships, faculty support, loan repayment assistance, awards, fellowships, and academic programs.

Endowments provide the Law School with dependable support in perpetuity. The initial gift is invested, and a portion of the fund’s market value (currently 4.5%) is awarded annually for the purpose designated by the benefactor. This giving opportunity allows benefactors to support their areas of interest now and into the future.

The University’s Board of Trustees has established minimum support levels for various types of endowments to guarantee that income will be adequate to achieve the benefactor's intent — now and in perpetuity. These endowments may be named in recognition of the generosity and vision of the donors or in honor or memory of persons of the donors' choice.
