



When arrested by ICE

1. You do not have to answer any questions or sign any paperwork without your lawyer
2. You have a right to a phone call. Memorize your lawyer's number or one emergency contact who can answer the phone or return your phone call, knows your emergency plan and has access to your deportation defense packet.

The Plan

Once you call your emergency contact they should be ready to do the following;

1. Get your Deportation Defense Packet.
2. Notify your loved ones and have them pick up your kids if at school. Children's school information should be in your Deportation Defense Packet.
3. Call ICE to get your A# and where you will be detained.

Emergency Contact needs to give ICE your full name, birthplace, and birth date, which is in your Deportation Defense Packet. Phone number and prisons addresses are also in your Deportation Defense Packet.

4. Contact either your Immigration lawyer or a lawyer that they know, and deliver your deportation defense packet to your lawyer.
5. Call the consulate of your home country and ask them not to issue travel documents until the lawyer has begun his work.

How to locate a loved one that is picked up by ICE

If your family member was detained by an immigration official, they are initially processed in the immigration headquarters in Philadelphia. When you call immigration, have the full name and date of birth of the individual who was detained. Make sure you have the month and year of their birthday, not just the numbers. You will also need their country of origin in order to locate them in immigration.

Call between 3 p.m. and 4 p.m. to ask for the A# of the individual (this is the identification number immigration assigns to all detainees.) and their detention center. The detention centers and the ICE office don't have bilingual staff, they only speak English.

We suggest that a family member sends a custody letter immediately to the detained individual that will instruct them not to sign any forms or speak to anyone without a lawyer. Individuals have the right to speak to a lawyer when they are communicating with any immigration official. It is possible to contact an immigration lawyer immediately in order to represent the individual in the court of law.

In order to send a letter to the detained individual, write their name followed by their A# and the address of the prison where they are detained. Undocumented individuals should not risk visiting the detention center.
