Why Use Conference-Springboard Worksheets?



Advantages:

Allows Students to Use Feedback

Provides Talking Points for Conference

Map for Follow-up and Future Work

Varying Level of Effort

Which "trigger facts" from <u>Bowles</u> did you include to show the parameters of the "scope of activity" standard?

How well did you explain the court's reasoning?

The Analysis

The Conclusion

Did you provide your reader with an answer to the issue you raised at the beginning of this CRAC?

Overall Assessment

- 1. What portion of your CRAC is the strongest?
- 2. Where do you see the most opportunity for improvement?
