<sup>i</sup> In June of 2014, the ABA approved Penn State's proposal to operate two separate and fully approved Penn State law schools: Penn State Law in University Park, PA, and Dickinson Law in Carlisle, PA. Currently, the law education program at Penn State University is provided through a single, unified law school with two campuses and all students enrolled in the unified school will remain in the unified school until graduation. Accordingly, much of the data normally published on this ABA form is not yet available for the separately-approved schools.
